For the avoidance of doubt the Purchaser JIIK Promotions and DJ Services Performance Contract shall, in addition to the charges in respect of the services

payments arising out of or associated with the cancellation including payment of full package price with forfeiture of applied discounts.

The Purchaser indemnifies, will reimburse and holds harmless JIIK Promotions and DJ Services, it's directors, officers, employees, agents, servants, and subcontractors from and against any and all claims, demands, suits, judgements, or causes of action including costs and expenses incidental thereto, for or on account of injury to or death of persons (including but not limited to employees, servants, and agents of the Purchaser) or for loss of or damage to property (including but not limited to the property of the Purchaser) howsoever arising out of the performance or non-performance of this Agreement and of whatever nature (whether in contract, tort under statute or otherwise at law or in equity) unless due to the recklessness of the DJ.
- 8. JIIK Promotions and DJ Services shall not be liable for any failure to perform its obligations or delay in performance of the same under this Agreement where such failure or delay is due to Acts Of God, war, invasion, military action, acts, orders, civil disturbance, strikes, lock outs, trade disputes causing cessation or slow-down of work, or inability to procure services or material after due and timely diligence, late deliveries or late performances of services from subcontractors or suppliers, breakdown of machinery (equipment included), fire, flood or accident or any cause beyond the reasonable control of JIIK Promotions and DJ Services whether or not similar to the causes specifically mentioned herein.

Additional terms and Conditions:

This agreement guarantees that the DJ will be ready to perform at the start time of the engagement. No guarantee is made as to the DJ's time of arrival, however, the DJ requests that they be permitted at least 2 hours before the engagement to set up and and hour to tear down. Purchasers fully understand that DJ has other employees (sub-contractors) that represent JIIK Promotions and DJ Services. In the event of an emergency to where Jeremiah Wilson can not perform said duties himself, he will ensure there will be an employee that will satisfy the terms of this agreement.
